

## Summer Student Employment Opportunities

Saskatchewan Health Authority (former Prairie North) is in the process of applying for federal funding under the 2022 Canada Summer Jobs program. **Pending approval of the funding** we will be recruiting summer students; these positions will include: Activities Student Worker(s), Therapy Student Worker(s), Pharmacy Student Worker(s), Nursing Assistant(s), and Public Health Nursing Assistants(s). Potential locations where the work will be performed are:

### Meadow Lake

- Northland Pioneer Lodge

### Rural

- Cut Knife Health Centre; L. Gervais Memorial Health Centre, Goodsoil; Loon Lake Health Centre & Special Care Home, Loon Lake; Lady Minto Health Centre, Edam; Maidstone Health Complex; Riverside Health Complex, Turtleford; St. Walburg Health Complex.

### Lloydminster

- Jubilee Home; Pharmacy, Lloydminster Hospital; and Prairie North Plaza.

### North Battleford

- River Heights Lodge; Primary Health Centre; and Battlefords District Care Centre, Battleford.

Preference will be given to **post-secondary students** who are enrolled in a health-related discipline such as Nursing, Therapies, Social Work, Pharmacy, Psychology, Health Information, etc. Job criteria require the students to be:

- be between 15 and 30 years of age at the start of the employment;
- be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the *Immigration and Refugee Protection Act* for the duration of the employment\*; and,
- have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.

\*International students are not eligible participants. International students include anyone who is temporarily in Canada for studies and who is not a Canadian citizen, permanent resident, or person who has been granted refugee status in Canada. Youth awaiting a refugee status ruling, as well as those who hold a temporary visitor visa, youth visa or work visa are ineligible.

The student can be hired on a temporary part-time or temporary full-time basis with a maximum of 40 hours per week, earliest job start date is April 25, 2022, and the latest job end date is September 3, 2022. These hours will vary depending upon the job/location. A criminal record check/Vulnerable Sector Check as well as Proof of Vaccination will be required. The rate of pay is \$15.00 per hour.
